

## **School Committee Report**

**March 3, 2014**

Concord Public Schools and the Concord-Carlisle Regional School District are committed to educating all students to become independent lifelong learners, creative thinkers, caring citizens, and responsible contributors to our increasingly diverse global society. The core values and beliefs include academic excellence, an empathic and respectful community, professional collaboration, educational equity, and continuous improvement.

The School Committees and Superintendent are dedicated to achieving these goals while maintaining a transparent public process related to policy decisions. #### **2014-2015 School Calendar Vote on Monday March 10**

The School Committees are reviewing options for the 2014-2015 school calendars. As the Committees review their calendar options, they are required to work within specific parameters set by state regulations and language contained in contracts with the Districts' collective bargaining units. In addition to the regulatory and contractual restrictions, members of the Committees are hearing concerns from students and families about the school calendar extending so late in June. The calendar can be an issue for many families as they consider educational programs, family plans, and summer camps that begin in late June.

The State requires a specific number of days and number of hours that students must be in school each year. Students must attend 180 days of school and teachers are required to work 185 days. All student and teacher days must be completed by June 30.

Language in the Concord Teachers Association (CTA) (K-8) and Concord-Carlisle Teachers Association (CCTA) (9-12) teachers' contracts stipulates that the District cannot require teachers to begin work until September 1 without consent of the unions. The CTA and CCTA currently have not agreed to begin prior to September 1.

**Given these restrictions, the Concord and Concord-Carlisle School Committees are considering a number of limited options to address these concerns including the elimination of the February vacation. The Committees will vote to approve 2014-2015 school calendar at the March 10 meeting.**
