### JOINT SCHOOL COMMITTEE MEETING MINUTES

# I. CALL TO ORDER CSC

Ms. Anderson called the CSC meeting to order at 9:00 AM.

# II. PUBLIC COMMENT

None.

# III. DISCUSSION

A. CPS FY24 Budget. Dr. Hunter shared an educational update to provide the comprehensive approach taken with the budget. She reviewed the impacts of the COVID pandemic, Strategic Planning goals 2018-2023, feedback from the Strategic Planning survey, overview of the mental health crisis, MCAS data, Special Education data including in district programs, analysis of in house verses out of district costs, circuit breaker carryover, special education fiscal spending, class sizes, student teacher ratios, CPS enrollment, CPS professional staff, CPS enrollment – NESDEC projections, per pupil spending, average teacher salary, 5 year trends, FY24 proposed budget, FY23 unfunded needs, and reductions to guideline.

To help frame the conversation, Mr. Booth noted that when the SC initially passed the budget, it was with the premise that they would revisit it to understand it in more detail. He stated that they are now taking a closer look and addressing the Finance Committee's efforts to move closer to the sustainable growth rate. The SC discussed the major drivers of the budget: teacher contracts, utilities and special education. Ms. Marano stated that she felt this budget was a reflection of special education and keeping students in district, advocating for keeping the special education programs. The SC discussed the increasing demands of mental health and Ms. Rainey asked that the SC review the Youth Risk Behavior survey results prior to finalizing the budget.

Mr. Booth questioned how class sizes are built out to produce a single average number and Dr. Hunter stated that she would provide the data available. He also suggested taking more of a risk on the contingency line before going to student facing lines and Mr. Conry stated that the FY24 budget does not have the safety net of ESSER and ARPA funds. Regarding the configuration of the classes, Mr. Booth stated that as enrollments drop and in-house programs are built, possible consolidations would have to be looked into. Dr. Hunter stated that a lot of this work has already been done. Ms. Marano noted the unknowns with METCO enrollment and the Best Western. Ms. Rainey asked that ESSER be broken out between FY23 and FY24 on the slides and also asked that the FY23 and FY22 circuit breaker be added as well. Mr. Booth suggested discussing the possible reductions to reach guideline and Ms. Anderson stated that she would like the Finance

Committee to have a chance to look at the data provided and make a counter offer before the SC discusses the reductions further. Dr. Hunter stated that 4.7% is a level service budget, noting that she is hoping that the SC supports her budget recommendation.

Ms. Marano called the CCSC meeting to order at 10:14 AM.

## II. ACTION ITEMS

A. Vote to Approve Nordic Ski Trip. Dr. Hunter noted that the Ski Team just qualified for this trip the previous week. A motion was made by Mr. Booth, seconded by Ms. Rankin, to approve the Nordic Ski Team trip to Vermont for February 14<sup>th</sup> as described by Dr. Hunter, subject to permission slips being signed by all student participants. The motion was approved by roll call: Anderson, aye; Booth, aye; Marano, aye; Rainey, aye; Rankin, aye; Whitt, aye; Wilson, aye.
